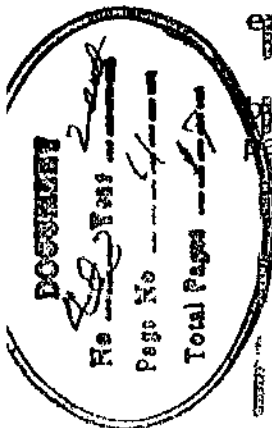
The power to appoint new trustees without exceeding the maximum number prescribed above, and to fill the vacancies in the Board of trustees.

No act or resolution of the Board of Trustee shall become invalid merely by reason of there being one or more vacancies in the Board of trustees.

In case of difference of opinion between the trustees the opinion of the majority shall prevail and if the trustees are equally divided in any matter, the managing trustee shall have a casting vote.
